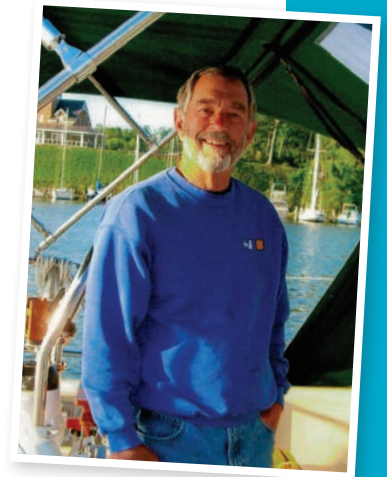

RWC's Economic Impact

Rappahannock Westminister-Canterbury depends upon the gifts and talents of staff members to provide a vast range of care and services for residents and clients, the skills and expertise of local businesses that provide necessary goods and services, and other local organizations that directly and indirectly support RWC and our residents, clients, and staff.

For our fiscal year 2021-2022, our payroll for staff living in the greater Northern Neck community exceeded \$8.4 million with an additional \$1.8 million to staff residing in the Middle Peninsula community.

During the same period, expenditures on goods, services, and capital assets were \$4 million in the Northern Neck and exceeded \$244,328 on the Middle Peninsula.

Yes, we do pay taxes as well. Our personal property, real estate, and sales tax expenditures were \$189,397 this fiscal year.

RWC Healthcare Education & Support Endowed Scholarship

The effects of the pandemic have touched all aspects of life. One area that has been hit particularly hard has been the workforce. Ginny Smithson Burnette noticed the recruiting and retention challenges in the health care system. After talking with Wanda Wallin, VP and Human Resources Director and Wade Bishop, VP and CFO, she realized that RWC was also being affected by the same challenges. Many nursing professionals are leaving long-term care to work for traveling nursing companies whose salaries are much higher. In order to recruit staff, we need to consider training people that are already in the area and help them reach their goals. We also need to showcase the rewards of a career in our field. Mrs. Burnette created a committee consisting of Mary Bennett, Phil Booth, Carl Blades, Katherine Lantz, Susan McKenna, and Pam Smith. This committee devised a solution to aid in sustaining healthcare staffing for the future: The RWC Healthcare, Education, and Support Endowed Scholarship (RHESES). What sets RHESES apart from our current scholarships is that it will provide an endowed fund with a target of \$500,000, and scholarships will be provided from earnings in that fund. This scholarship will also include an employment commitment of the student to work at RWC for



an amount of time commensurate to the funds they receive. Our current scholarship funds will soon be depleted. In order to attract and maintain the high-quality nursing staff needed to care for present and future residents, please consider donating to RHESES. We have received \$24,000 in the short time since it was created. Now we need your help to make this mission a success. You may make a one-time donation or choose to make payments monthly or quarterly. Thank you for your generosity!

A rich vocabulary enhances your conversations. But did you know you can also turn a quick vocabulary lesson into a stimulating mind game. Many more regions of the mind are involved in vocabulary tasks, particularly in areas that are important for visual and auditory processing.

Dance your heart out

Learning new dance moves can increase your mind's processing speed and memory. In other words, put on your dancing shoes and your mind will thank you.

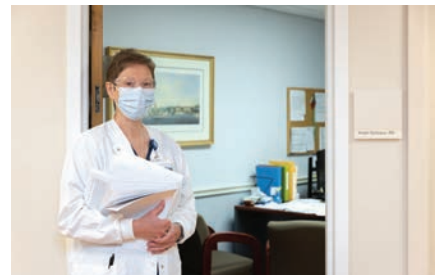
