

RWC's Economic Impact

At Rappahannock Westminister-Canterbury, we truly value and rely on our dedicated staff members' exceptional gifts and talents who work tirelessly to provide a wide array of care and services to our residents and clients. We also deeply appreciate the skills and expertise of our local business partners who supply us with essential goods and services, as well as the unwavering support from various local organizations that directly and indirectly contribute to the well-being of RWC and everyone we serve. In our recent fiscal year 2023-2024, our payroll for staff members residing in the greater Northern Neck community surpassed \$9.9 million, with an additional \$2.2 million allocated for those living in the Middle Peninsula community. Furthermore, our expenditures on goods, services, and capital assets amounted to \$2.7 million in the Northern Neck region and exceeded \$141,015 million on the Middle Peninsula. Rest assured, we also fulfill our tax obligations diligently, with personal property, real estate, and sales tax expenditures totaling \$193,593 for the fiscal year. We are immensely grateful for the collaborative efforts and continuous support that enable us to thrive and make a positive impact on our community.

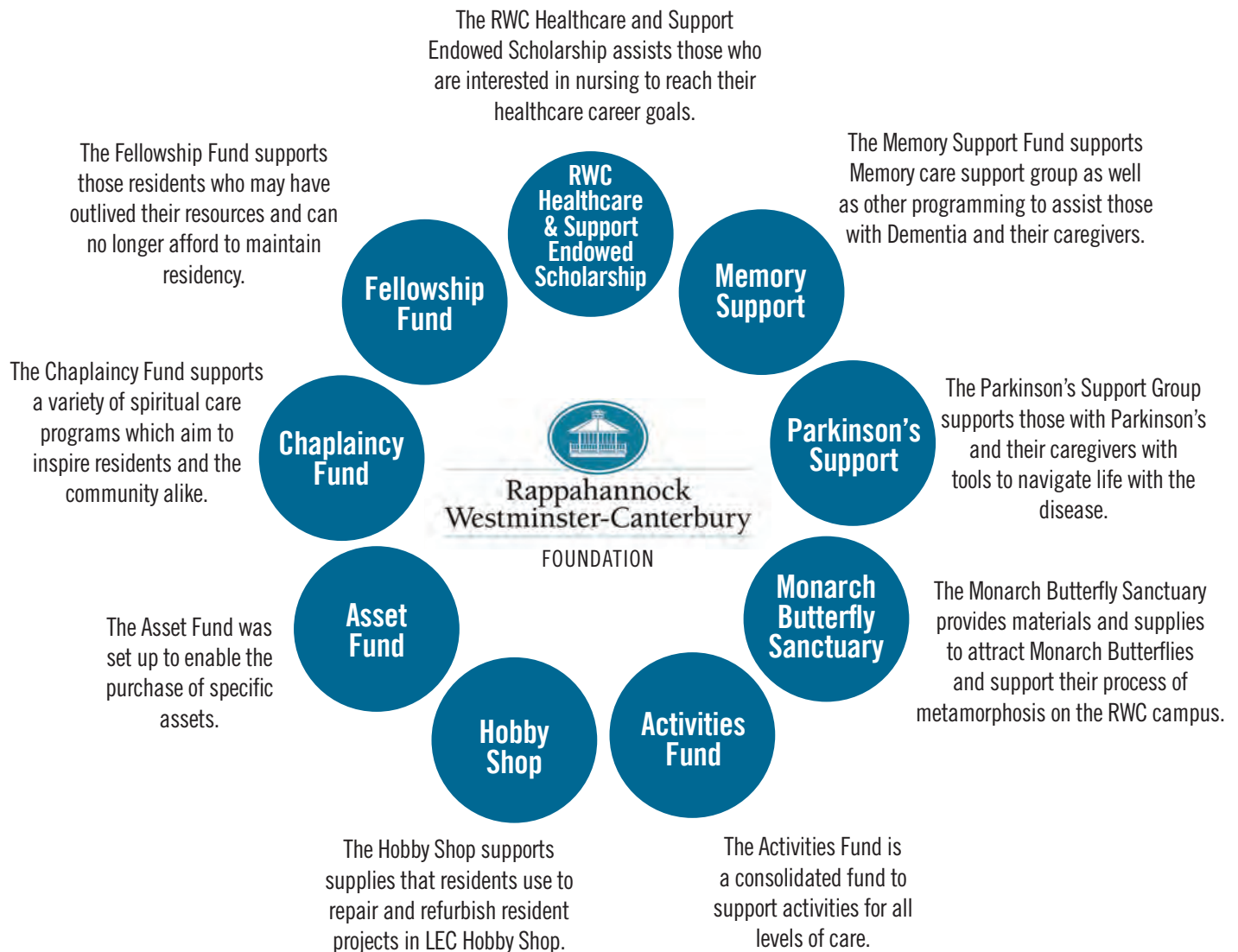
