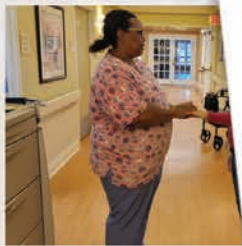
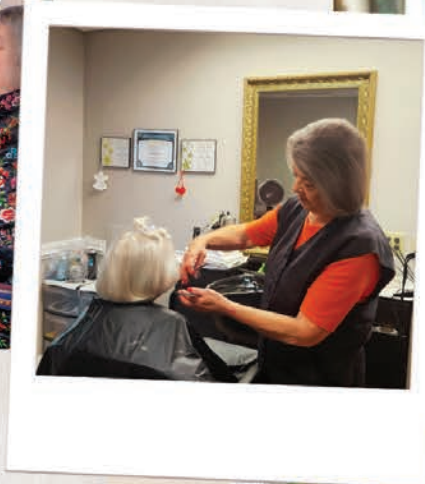

RWC’s Economic Impact

At Rappahannock Westminster-Canterbury (RWC), we are proud to rely on the extraordinary dedication, skill, and compassion of our remarkable staff, who provide a comprehensive range of care and services to our residents and clients each day. Their commitment and compassion form the foundation of everything we do.

We are equally grateful for the valued partnerships we share with local businesses and organizations. These collaborations are essential to our success—providing critical goods, services, and support that strengthen both our operations and the well-being of those we serve.

In fiscal year 2024–2025, RWC’s impact on the local economy was significant. Our payroll contributions exceeded \$9.6 million for employees residing in the greater Northern Neck community, with an additional \$2 million paid to staff residing in the Middle Peninsula. We also invested over \$972,888 in goods, services, and capital assets in the Northern Neck, and more than \$3.8 million in the Middle Peninsula.

Beyond employment and procurement, we continue to meet our civic responsibilities, contributing a total of \$236,624 in personal property, real estate, and sales taxes during the fiscal year.

These numbers tell a powerful story—one of partnership, economic vitality, and shared purpose. We are deeply thankful for the ongoing collaboration and steadfast support that enable RWC not only to thrive, but also to enrich the lives of those in our care and across our broader community.

Heart and Harmony: Celebrating Vicki Smith's Dedication to RWC

Making a difference, one song at a time

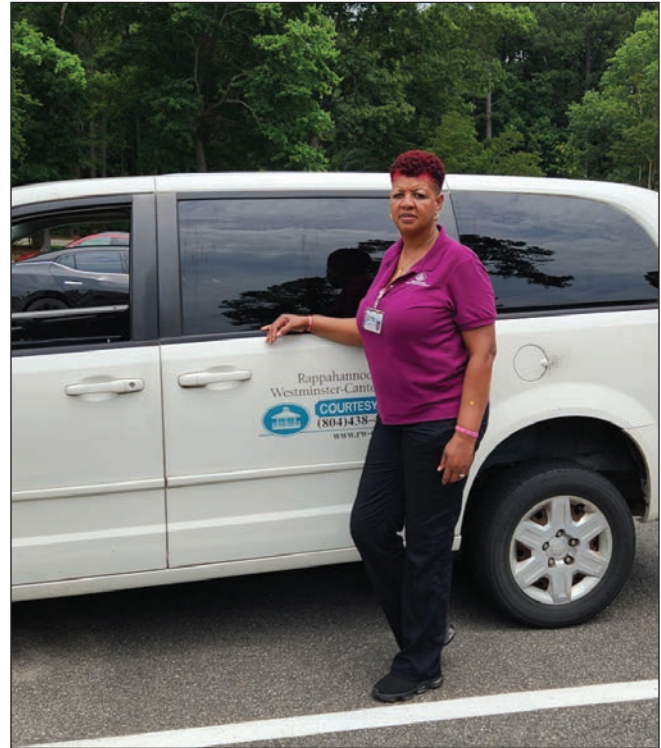
One of the most remarkable things about Rappahannock Westminister-Canterbury (RWC) is the deep sense of commitment shown by our staff—many of whom have dedicated over three decades of service to our community. These employees have not only built meaningful careers here, but have also raised families of their own while contributing daily to the RWC family.

Among these long-serving team members, one name stands out: **Vicki H. Smith**, our longest-tenured employee, who began her journey with RWC on **June 17, 1986**. Vicki started as a **Certified Nursing Assistant (CNA)** on the 3–11 p.m. shift in the Health Center. At the time, our Assisted Living Center hadn't even been built.

As RWC grew, so did Vicki's role. She was promoted to **Transportation Aide in Assisted Living**, where she continues to accompany residents to local appointments. Along the way, she completed the **Registered Medication Aide (RMA)** course under the late Sandra Madison, becoming a dual-certified **RMA/CNA**. Vicki is known for her flexibility and strong work ethic—always willing to step in wherever she's needed.

What truly sets Vicki apart is her joyful spirit. She's often heard singing or humming as she works, bringing comfort and delight to residents. One resident even makes a special request for a song every time she sees Vicki, calling her music a blessing and a ministry.

Vicki isn't alone in her dedication. Many of her colleagues in Assisted Living have also been part of the RWC family for over 30 years. Together, they form a compassionate, hardworking team focused on resident care and support.



Reflecting on her career, Vicki shares: *"If I can make someone smile with a song, that makes my job easy."* Her warmth, talent, and devotion have left a lasting impression on the RWC community—and we are incredibly grateful for her continued service.

Rappahannock Westminster- Canterbury: A Legacy of Compassionate Care, and Innovation



Rappahannock Westminster-Canterbury (RW-C) has always stood as a beacon of compassionate care, service, and forward-thinking innovation. According to Cynethia Davis, our Assisted Living Administrator, when she began her journey here in 1990, the only medical facilities on campus were the Health Center and the Clinic. At that time, Assisted Living was in its infancy, and regulations were evolving. Soon, a new requirement emerged: Medication Aides had to be officially registered through the Board of Nursing.

This change sparked a wave of innovation at RW-C, led by the late Sandra Madison, along with Sheila Wright and Tonia Waddy. Under their leadership, RW-C launched an in-house training program to certify staff as Registered Medication Aides (RMAs) and Certified Nursing Assistants (CNAs). Not only was RW-C a training ground—it also became a certified testing site. Thanks to the dedication and expertise of instructors Sandra Madison and Tonia Waddy, the program saw remarkable success, boasting a 100% pass rate for students.

Although the program paused after Sandra Madison's passing, RW-C's spirit of innovation lives on—and is stronger than ever.

Today, RW-C is once again stepping into the future of healthcare with bold new initiatives. Wanda Wallin, our Vice President of Human Resources, has launched two major programs to recruit and retain skilled nurses, using Nursing Scholarship Funds to fuel this vision.

The first initiative is a partnership with Peace of Mind Training Center in White Stone. This program provides individuals with no prior medical experience the opportunity to become CNAs. Thanks to this effort, we now proudly welcome three new CNAs and one newly registered RMA to our team.

The second initiative is an exciting collaboration with Global Talent Specialists, aimed at bringing exceptional Filipino nurses to RW-C. This rigorous two- to three-year process involves vetting, training, and securing government visas and licensure for these highly qualified candidates. If all goes as planned, we anticipate welcoming these international nurses to RW-C by the end of 2026.

From local training to global recruitment, RW-C continues to honor its legacy while embracing the future—with compassion, care, and innovation at its core.

May we continue to uphold the legacy they began—serving with the same kindness, strength, and unwavering compassion that defined their lives and work.

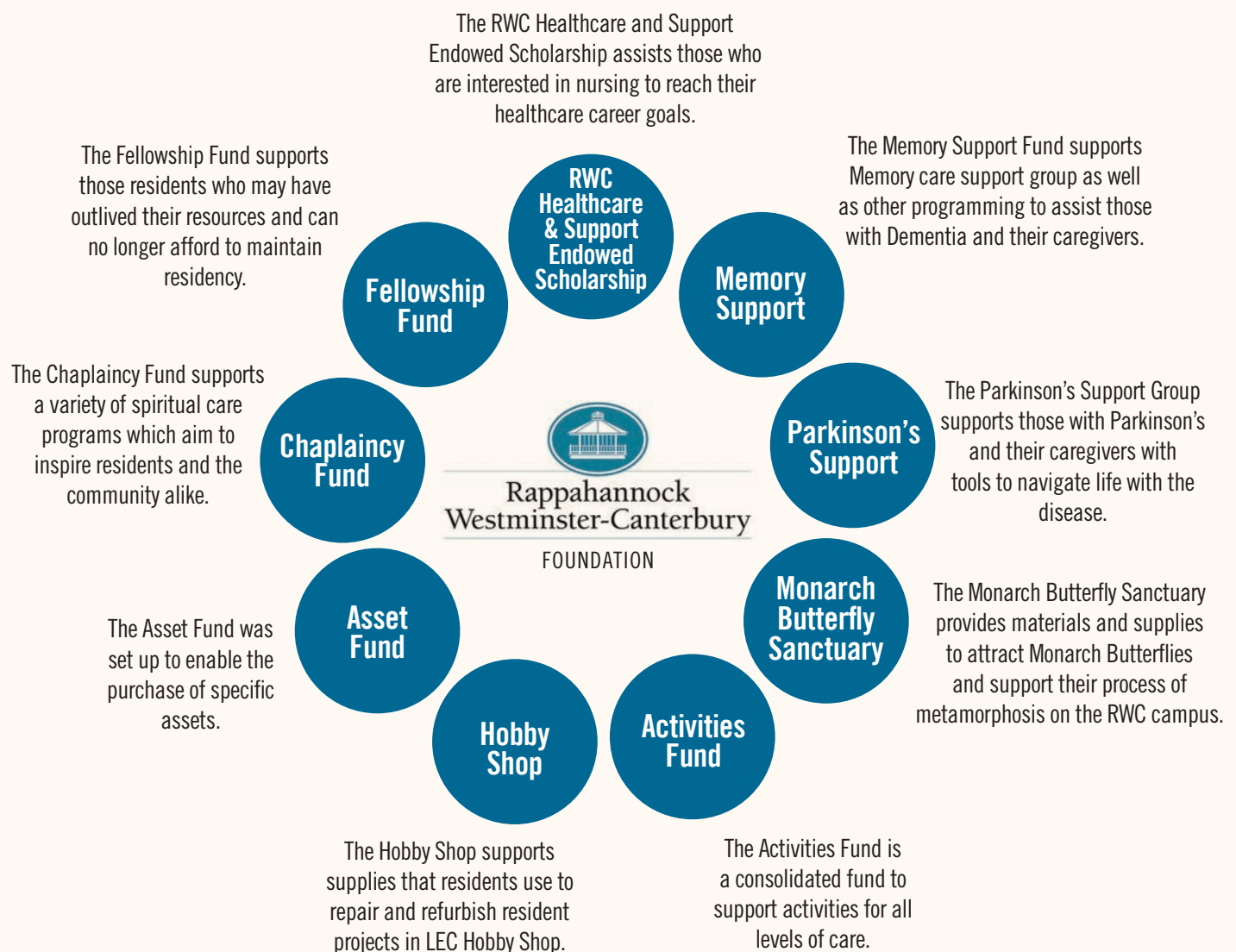
